## APPLICATION FOR PARTIAL PAYMENT - 2022 CURRENT YEAR TAXES

Section 197.374 Florida Statutes and Tax Collector policy allow for partial payments on current year taxes. Applications are accepted by the Tax Collector's Office starting November 1 and must be submitted on or before March 31 of the following year.

Applicants in the partial payment plan agree to an additional \$10.00 processing fee per payment and forfeit any applicable discounts. Minimum partial tax payment remitted must be \$100.00 plus the processing fee (as mandated by law).

March 31 is the last day to make a payment on the partial payment plan. Any remaining balance that is not paid before April 1st becomes delinquent and applicable interest and fees will be added. If taxes are not paid, a tax certificate will be issued on the remaining balance and your property may be sold at a future date.

Taxpayers who are currently on the Installment Payment Plan are not eligible for the Partial Payment Plan. Taxpayers who maintain an escrow account with their mortgage company to pay for property taxes should not participate in the Partial Payment Plan.

Please read and initial all information points listed below. If the property is jointly owned, only one signature is required. Failure to initial all points will result in this Application being returned.
