



When a conforming MCO is submitted as proper proof of ownership for a motor vehicle or vessel and more than one dealer is involved, reassignment from dealer to dealer must appear in sequence on the reverse side of the MCO. However, subsequent motor vehicle dealers must use form HSMV 82994, Motor Vehicle Title Reassignment Supplement (Florida dealer) or a separate dealer reassignment (out-of-state dealer), if the conforming MCO is not available at the time of sale.

A duplicate MCO is only acceptable if accompanied by an affidavit from the selling dealer stating that the original MCO was lost or destroyed and that the MCO has not previously been submitted with an application for certificate of title in any state.





Application for Title & Registration Using an MCO

The following documents are required to complete a title transfer using an MCO:

- MCO (Manufacturer's Certificate of Origin)
- Properly Completed Reassignments
- HSMV 82040 Application for Florida Title
- Acceptable Customer Identification
- Lien Satisfaction (If Applicable)
- Sales Tax (document amount collected on HSMV 82040, section 7)
- Proof of Florida Insurance
- License Plate Number for Transfer/Replacement or Non-Use Affidavit (HSMV 82040, section 11)
- Fees
